**WHEREAS**, the Roy & Christine Sturgis Charitable Trust has awarded grant funds to the City of Dallas to restore and celebrate the legacy of the Honorable Juanita J. Craft and the Juanita J. Craft Civil Rights House & Memorial Garden; and

**WHEREAS**, Bank of America, NA., as co-trustee of the Roy & Christine Sturgis Charitable Trust, requires a grant agreement be signed ensuring that the funds are used exclusively for the restoration and celebration of the Juanita J. Craft Civil Rights House & Memorial Garden; and

**WHEREAS**, the City of Dallas will benefit from the funds for the preservation and restoration of the Juanita J. Craft Civil Rights House & Memorial Garden.

**Now, Therefore,**

**BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF DALLAS:**

**SECTION 1.** That the City Manager is hereby authorized to accept a grant from the Roy & Christine Sturgis Charitable Trust Care of Communities Foundation of Texas, approved as to form by the City Attorney, to preserve and restore the Juanita J. Craft Civil Rights House in the amount of \$15,000.00 for the period June 30, 2021 through June 30, 2022, and execute the grant agreement with Roy & Christine Sturgis Charitable Trust and Bank of America, NA, as Co-Trustee, and all terms, conditions, and documents required by the agreement.

**SECTION 2.** That the Chief Financial Officer is hereby authorized to receive and deposit grant funds in an amount not to exceed \$15,000.00 in the Sturgis Charitable Trust Grant Fund, Fund P155, Department OCA, Unit 224C, Revenue Code 8411.

**SECTION 3.** That the City Manager is hereby authorized to establish appropriations in an amount not to exceed \$15,000.00 in the Sturgis Charitable Trust Grant Fund, Fund P155, Department OCA, Unit 224C, Object 3070.

**SECTION 4.** That the Chief Financial Officer is hereby authorized to disburse funds in the amount of \$15,000.00 from the Sturgis Charitable Trust Grant Fund, Fund P155, Department OCA, Unit 224C, Object 3070.

**SECTION 5.** That the City Manager is hereby authorized to reimburse to the granting agency any expenditures identified as ineligible. The City Manager shall notify the appropriate City Council Committee of expenditures identified as ineligible not later than 30 days after the reimbursement.

**SECTION 6.** That the City Manager shall keep the appropriate City Council Committee informed of all final granting agency monitoring reports not later than 30 days after the receipt of the report.

**SECTION 8.** That this resolution shall take effect immediately from and after its passage in accordance with the provisions of the Charter of the City of Dallas, and it is accordingly so resolved.
