**WHEREAS**, the Motor Vehicle Crimes Prevention Authority (MVCPA) has made funds available for law enforcement projects during the 2021-22 fiscal year; and

**WHEREAS**, the increased funding source would benefit the City of Dallas in its endeavor to reduce crime; and

**WHEREAS**, under the provisions of the Texas Revised Civil Status Article 4413(37) and Texas Administrative Code Title 43; Part 3; Chapter 57, entities are eligible to receive grants from the MVCPA to provide financial support to law enforcement agencies for economic automobile theft enforcement teams and to combat automobile burglary in the jurisdiction; and

**WHEREAS**, this grant program will assist this jurisdiction to combat automobile burglary and theft; and

**WHEREAS**, the City of Dallas has agreed that in the event of loss or misuse of the grant funds, the City of Dallas assures that the grant will be returned in full to the MVCPA.

**Now, Therefore,**

**BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF DALLAS:**

**SECTION 1.** That the City Manager is hereby authorized to accept funding for the Commercial Auto Theft Interdiction Squad/29 Grant (Grant No. 608-22-DPD0000) from the MVCPA in the amount of \$797,339.00 to provide a specialized proactive automobile theft program for the period September 1, 2021 through August 31, 2022; and execute the grant agreement and all terms, conditions, and documents required by the grant agreement, approved as to form by the City Attorney.

**SECTION 2.** That the City Manager is hereby authorized to establish appropriations in an amount not to exceed \$797,339.00 in FY22 MVCPA-Commercial Auto Theft Interdiction Squad/29 Fund, Fund S370, Department DPD, Unit 231C, various Object Codes in accordance to the attached Schedule A.

**SECTION 3.** That the Chief Financial Officer is hereby authorized to receive and deposit grant funds in an amount not to exceed \$797,339.00 in the FY22 MVCPA-Commercial Auto Theft Interdiction Squad/29 Fund, Fund S370, Department DPD, Unit 231C, Revenue Code 6516.

**SECTION 4.** That the Chief Financial Officer is hereby authorized to disburse funds in an amount not to exceed \$797,339.00 from FY22 MVCPA-Commercial Auto Theft Interdiction Squad/29 Fund, Fund S370, Department DPD, Unit 231C, various Object Codes, in accordance to the attached Schedule A.

**SECTION 5.** That the Chief Financial Officer is hereby authorized to provide a local cash match in an amount not to exceed \$176,785.00 (subject to appropriations) from General Fund, Fund 0001, Department DPD, Unit 2161, various Object Codes in accordance to the attached Schedule A.

**SECTION 6.** That the Chief Financial Officer is hereby authorized to provide an In-Kind Contribution in the approximate amount of \$824,570.00, in accordance to the attached Schedule A.

**SECTION 7.** That in the event of loss or misuse of funds, the City of Dallas will return all funds to the Motor Vehicle Crimes Prevention Authority in full. The City Manager shall notify the appropriate City Council Committee of expenditures identified as ineligible not later than 30 days after the reimbursement.

**SECTION 8.** That the City Manager shall keep the appropriate City Council Committee informed of all final granting agency monitoring reports not later than 30 days after the receipt of the report.

**SECTION 9.** That this contract is designated as Contract No. DPD-2021-00017182.

**SECTION 10.** That this resolution shall take effect immediately from and after its passage in accordance with the provisions of the Charter of the City of Dallas, and it is accordingly so resolved.
