**WHEREAS**, the City of Dallas established an Adult Treatment Drug Court Expansion Project that seeks to expand the South Dallas Community Drug Court into a Treatment Drug Court that will incorporate alcohol/drug treatment, recovery support services, screening, assessment, case management, and program coordination; and

**WHEREAS**, on August 8, 2018, the U.S. Department of Health and Human Services (HHS), Substance Abuse and Mental Health Services Administration (SAMHSA), awarded the City a five-year grant with the project period of September 30, 2018 through September 29, 2023, to offer individuals facing criminal charges for substance abuse and possession an opportunity to enter a substance abuse recovery program in lieu of jail time; and

**WHEREAS**, on August 26, 2020, City Council authorized the acceptance of the Substance Abuse and Mental Health Services Administration (SAMHSA) Grant from the U.S. Department of Health and Human Services (HHS) (Grant No. 5H79TI081081-03, CFDA No. 92.243) in the amount of \$343,639.00, to expand substance abuse capacity at the existing South Dallas Drug Court (SDDC) for the period September 30, 2020 through September 29, 2021, and execution of the grant agreement and all terms, conditions, and documents required by the agreement by Resolution No. 20-1214; and

**WHEREAS**, on August 26, 2020, City Council authorized the City Manager to establish appropriations in an amount not to exceed \$343,639.00 in the SAMHSA-Adult Treatment Drug Court Expansion Project 20-21 Fund, Fund F631, Department ATT, Unit 121C; and authorized the Chief Financial Officer to receive and deposit grant funds in an amount not to exceed \$343,639.00 into the SAMHSA-Adult Treatment Drug Court Expansion Project 20-21 Fund, Fund F631, Department ATT, Unit 121C, Revenue Code 6506; and authorized the Chief Financial Officer to disburse grant funds in an amount not to exceed \$343,639.00 from the SAMHSA-Adult Treatment Drug Court Expansion Project 20-21 Fund, Fund F631, Department ATT, Unit 121C, various Object Codes by Resolution No. 20-1214; and

**WHEREAS**, on December 7, 2020, Administration Action No. 20-6265, the City Manager authorized a contract between the City of Dallas and Golden Gate Adult Rehabilitation Ministry, Inc. to provide recovery support services at the South Dallas Drug Court (SDDC) for FY 20-21, in an amount not to exceed \$50,000.00; and

**WHEREAS**, on May 26, 2021, City Council authorized Supplemental Agreement No. 1 to the subrecipient agreement with Golden Gate Adult Rehabilitation Ministry, Inc. for additional recovery support services at the SDDC for FY 20-21 in the amount of \$50,000.00, from \$50,000.00 to \$100,000.00 by Resolution No. 21-0875; and

**WHEREAS**, payment for additional recovery support services rendered by Golden Gate Adult Rehabilitation Ministry, Inc. for FY 20-21, is necessary.

**Now, Therefore,**

**BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF DALLAS:**

**SECTION 1.** That the City Manager is hereby authorized to execute Supplemental Agreement No. 2 to the subrecipient agreement with Golden Gate Adult Rehabilitation Ministry, Inc., approved as to form by the City Attorney, for payment of additional recovery support services rendered at the South Dallas Drug Court for FY 20-21, in an amount not to exceed \$15,000.00, increasing the contract amount from \$100,000.00 to \$115,000.00.

**SECTION 2.** That the Chief Financial Officer is hereby authorized to disburse funds in an amount not to exceed \$15,000.00, in periodic payments to Golden Gate Adult Rehabilitation Ministry, Inc., from the SAMHSA-Adult Treatment Drug Court Expansion Project 20-21 Fund, Fund F631, Department ATT, Unit 121C, Object 3070, Encumbrance/Contract No. ATT-2021-00015135, Vendor VS0000021798.

**SECTION 3.** That this resolution shall take effect immediately from and after its passage in accordance with the provisions of the Charter of the City of Dallas, and it is accordingly so resolved.
