WHEREAS, a lawsuit styled Juana Segovia, Individually and as Personal Representative of the Estate of Juan Segovia Ramirez, Manuel Segovia, Individually, Angie Segovia, Individually, and Evelyn Segovia, Individually v. City of Dallas, Texas, Alexis Booker-Lewis, Ashleigh Warren, Michael Rumsey, Craig Houston, Robert Beck, Kenneth Brown, Maxwell Boeckel, and Rodney Featherston, Civil Action No. 3:21-CV-1514-K, was filed by the Plaintiffs, Juana Segovia, Manuel Segovia, Angie Segovia, and Evelyn Segovia, seeking compensation from the City of Dallas, City employees Craig Houston, Robert Beck, Kenneth Brown, and Rodney Featherston, and former City employees Alexis Booker-Lewis, Ashleigh Warren, Michael Rumsey, and Maxwell Boeckel for alleged injuries and other damages sustained when they failed to provide medical assistance to Juan Segovia Ramirez on June 30 – July 1, 2019; and

WHEREAS, the Plaintiffs have agreed to a proposed settlement of the case whereby the City will pay Juana Segovia, Individually and as Personal Representative of the Estate of Juan Segovia Ramirez, Manuel Segovia, Individually, Angie Segovia, Individually, and Evelyn Segovia, Individually, and Scott H. Palmer, P.C., and all other persons having an interest in the settlement proceeds, the total amount of \$1,000,000.00; and

WHEREAS, it is in the best interest of the City to settle this lawsuit.

Now, Therefore,

BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF DALLAS:

SECTION 1. That the proposed settlement of the lawsuit styled <u>Juana Segovia</u>, <u>Individually and as Personal Representative of the Estate of Juan Segovia Ramirez</u>, <u>Manuel Segovia</u>, <u>Individually</u>, <u>Angie Segovia</u>, <u>Individually</u>, <u>and Evelyn Segovia</u>, <u>Individually</u> v. City of Dallas, Texas, Alexis Booker-Lewis, Ashleigh Warren, Michael Rumsey, Craig Houston, Robert Beck, Kenneth Brown, Maxwell Boeckel, and Rodney <u>Featherston</u>, Civil Action No. 3:21-CV-1514-K, in an amount not to exceed \$1,000,000.00 is hereby approved.

SECTION 2. That the Chief Financial Officer is hereby authorized to pay Juana Segovia, Individually and as Personal Representative of the Estate of Juan Segovia Ramirez, Manuel Segovia, Individually, Angie Segovia, Individually, and Evelyn Segovia, Individually, and Scott H. Palmer, P.C., and all other persons having an interest in the settlement proceeds, the amount of \$1,000,000.00 from Liability Reserve Fund, Fund 0192, Department ORM, Unit 3890, Object 3521, Vendor MVORM001.

SECTION 3. That this resolution shall take effect immediately from and after its passage in accordance with the provisions of the Charter of the City of Dallas, and it is accordingly so resolved.
