WHEREAS, on February 27, 2013, City Council authorized a three-year service contract, with two three-year renewal options, for dock master services at Dallas Love Field with Bradford Airport Logistics LTD, in an amount not to exceed \$2,084,874.00, by Resolution No. 13-0377; and

WHEREAS, on March 23, 2016, City Council authorized (1) the first three-year renewal option to the service contract with Bradford Airport Logistics, LTD, for dock master services at Dallas Love Field in the amount of \$2,084,874.00; and (2) an increase in the contract for additional services related to the x-ray inspection system in the amount of \$191,728.00, in a total amount not to exceed \$2,276,602.00, by Resolution No. 16-0414; and

WHEREAS, on June 26, 2019 City Council authorized Supplemental Agreement No. 2 to exercise the second three-year renewal option to the service contract with Bradford Airport Logistics, LTD, for dock master services at Dallas Love Field for the Department of Aviation, by Resolution No. 19-1028; and

WHEREAS, Bradford Airport Logistics, LTD has been an excellent operator, especially during the COVID-19 pandemic when airline traffic was significantly reduced, with staffing reductions, supply chain issues and concession sales lost. Contractor continued operations to service the concessionaires in a very trying climate; and

WHEREAS, for Bradford Airport Logistics, LTD to assist the concession program to recover from the COVID-19 pandemic period and continue to service the concessionaires, it is important to exercise a third renewal agreement for a period of three years. This renewal term will provide enhancements to current services by (1) raising the minimum hourly rate for all Bradford employees from \$14.00 to \$17.00 per hour retroactive to October 1, 2021 and (2) replacing the x-ray pallet scanner with the most current scanning capability available to enhance the inspection process. The additional enhancements will increase the contract amount by \$395,890.00, in a total amount not to exceed \$3,246,192.00.

Now, Therefore,

BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF DALLAS:

SECTION 1. That the City Manager is hereby authorized to execute Supplemental Agreement No. 3 to exercise a third three-year renewal option to the service contract with Bradford Airport Logistics, LTD, approved as to form by the City Attorney, for dock master services at Dallas Love Field for the Department of Aviation, in an amount not to exceed \$3,246,192.00.

SECTION 2. That the Chief Financial Officer is hereby authorized to disburse funds in an amount not to exceed \$3,246,192.00 (subject to annual appropriations) to Bradford Airport Logistics, LTD from the Aviation Fund, Fund 0130, Department AVI, Unit 7730, Object 3092, Vendor VS0000075481.

SECTION 3. That this contract is designated as Contract No. AVI-2019-00010596.

SECTION 4. That this resolution shall take effect immediately from and after its passage in accordance with the provisions of the Charter of the City of Dallas, and it is accordingly so resolved.
