**BACKGROUND**

This item will authorize position additions, deletions, reclassifications, upgrades, downgrades, and

transfers as a result of revised program goals and budget decisions recently recommended to the City Council.

The recommended FY 2022-23 Civilian Salary Schedules increases the lowest minimum hiring rate to \$18.00 effective January 1, 2023, payable the first pay period of the calendar year.

It is necessary to ratify these actions and to amend the civilian pay plans in conjunction with the approved budget authorizing these changes
