BACKGROUND

The Texas Department of Transportation (TxDOT) is reconstructing traffic signals at the intersection of State Highway 78 at Garland Road; Gaston Avenue; and East Grand Avenue. The traffic signal improvements at the intersection will include upgrades to pedestrian features, signage, pavement markings, and reconstruction of traffic signals.

To remain consistent with other equipment in the City-wide system, the City of Dallas will provide a controller, cabinet, radar detection equipment, traffic signs, and battery backup equipment for the project. TxDOT will reimburse the City for material and labor costs.

Begin Construction July 2021
Complete Construction March 2022

PRIOR ACTION/REVIEW (COUNCIL, BOARDS, COMMISSIONS)

On March 27, 2019, City Council authorized an Agreement to Contribute Right-of-Way Funds between the City of Dallas and the Texas Department of Transportation (RCSJ 0009-02-071, CCSJ 0009-02-067) for the purpose of acquiring right-of-way and relocating or adjusting utilities at the intersection of Grand Avenue, Gaston Avenue, and Garland Road by Resolution No. 19-0447.
