BACKGROUND

On June 4, 2024, the Ad Hoc Judicial Nominations Committee met to discuss the 3% increase and appointment process of the Municipal judges based on previous practice in preparation for the Municipal judge term that ends on May 31, 2024.

The 3% increase for the Administrative Judge, Municipal Judges, and Associate Judges effective on

the beginning of the first pay period after Council's approval. The following analysis and recommendation based on market data is listed below and if approved the new amount will be programed in the FY 2024-25 reported budget.

- Associate Judges are going from \$66.10 to \$68.08 (3%)
- Municipal Judges are going from \$140,000.00 to \$144,200.00 (3%)
- Administrative Judge is going from \$155,000.00 to \$159,650.00 (3%)
