**BACKGROUND**

This action will authorize a construction services contract with Estrada Concrete Company, LLC for the construction of three alley reconstruction projects as Alley Reconstruction Group 17-1488.

The scope of the project group will include the construction of reinforced concrete pavement, driveways, water and wastewater lines and other miscellaneous items necessary to complete the

project in accordance with the plans and specifications.

Following are the locations and construction costs for each project:
