**BACKGROUND**

This action will authorize the receipt and deposit of a private donation from the Dallas Symphony Association, Inc. to increase the architectural services contract with Harrison-Kornberg Architects, LLC, for additional design services for roofing renovations at the Meyerson Symphony Center, a project approved by the citizens of Dallas in the 2017 Bond Program. Dallas Symphony Association, Inc. is contributing \$40,370.00 towards the architectural, and engineering design, and construction administration services.

This action will also authorize Supplemental No. 1 to increase the architectural services contract with Harrison-Kornberg Architects, LLC for additional design services and construction administration at Meyerson Symphony Center located at 2301 Flora Street.

Deferral of this item would delay design solution for additional roofing repairs located in the facility.
