PRIOR ACTION/REVIEW (COUNCIL, BOARDS, COMMISSIONS)

City Council was briefed in Executive Session on June 6, 2018.

On June 13, 2018, City Council authorized Supplemental Agreement No. 1 to the professional

services contract with Ogletree, Deakins, Nash, Smoak & Stewart, P.C., for additional legal services to represent the City of Dallas in the lawsuit styled Terrance Bass, et al. v. City of Dallas by Resolution No. 18-0807.

On April 10, 2019, City Council authorized Supplemental Agreement No. 2 to the professional services contract with Ogletree, Deakins, Nash, Smoak & Stewart, P.C., for additional legal services to represent the City of Dallas in the lawsuit styled Terrance Bass, et al. v. City of Dallas by Resolution No. 19-0486.

City Council was briefed by memorandum regarding this matter on September 20, 2019.

On September 25, 2019, City Council authorized Supplemental Agreement No. 3 to the professional services contract with Ogletree, Deakins, Nash, Smoak & Stewart, P.C., for additional legal services to represent the City of Dallas in the lawsuit styled Terrance Bass, et al. v. City of Dallas by Resolution No. 19-1475.
