BACKGROUND

This action will authorize a construction services contract with Aushill Construction, LLC for the construction of three street reconstruction projects as Street Reconstruction Group 17-1103.

The project group scope will include replacing the existing deteriorating streets with new reinforced concrete pavement, curb, gutter, driveway approaches, sidewalks, storm drainage, water and

wastewater improvements, and other miscellaneous items necessary to complete the project in accordance with the plans and specifications.
