**SUBJECT**

Authorize a three-year master agreement for the purchase of valves, valve parts, and accessories for the Water Utilities Department - Mueller Co., LLC. in the estimated amount of \$1,203,722, Municipal Valve & Equipment Company, Inc. in the estimated amount of \$310,814, and Valve & Equipment Consultants, Inc in the estimated amount of \$5,000, lowest responsible bidders of three - Total estimated amount of \$1,519,536 - Financing: Dallas Water Utilities Fund

**BACKGROUND**

This action does not encumber funds; the purpose of a master agreement is to establish firm pricing for goods, for a specific term, which are ordered on an as needed basis according to annual budgetary appropriations. The estimated amount is intended as guidance rather than a cap on spending under the agreement, so that actual need combined with the amount budgeted will determine the amount spent under this agreement.

This master agreement will provide for the purchase of valves, valve parts, and accessories for the

Water Utilities department. The valves, valve parts, and accessories will be used to repair, and replace valves as needed, allowing the City to maintain its water system to specified standards.

The agreement will be used to purchase safety and control valves that set, release, start, and stop pressure throughout the City's piping systems. These valves will also regulate the flow of liquids, gases, and air. The Water Utilities Department maintains over 5,000 miles of water mains throughout the water distribution system and close to 4900 miles of sewer lines in the wastewater collection system.

The City replaces approximately 200 valves annually due to aging and standard wear and tear. An additional 200 valves are repaired annually during routine maintenance activities. These valves are in constant use regulating the flow of water, wastewater, sludge, treatment chemicals, etc., which require regular repair and replacement, and covers as needed. Emergency crews respond to missing/damaged manhole and inlet lid covers to address roadway hazards.

As part of the solicitation process and in an effort to increase competition, the Office of Procurement Services used its procurement system to send out email notifications to vendors registered under relevant commodity codes. To further increase competition, the Office of Procurement Services uses historical solicitation information, the Internet, and vendor contact information obtained from user departments to contact additional vendors.

**PRIOR ACTION/REVIEW (COUNCIL, BOARDS, COMMISSIONS)**

On August 24, 2016, City Council authorized a three-year master agreement for valves, valve parts and accessories with Mueller Co., Fortiline, Inc., ACT Pipe & Supply, Inc., Municipal Valve & Equipment Co., Inc., and Powerseal Pipeline Products Corp. by Resolution No. 16-1309.
