BACKGROUND

This action will authorize a construction services contract with Aushill Construction, LLC for the construction of five alley reconstruction projects as Alley Reconstruction Group 17-3001.

The project group scope will include replacing the deteriorating alleys with reinforced concrete pavement, driveway approaches, storm drainage, water and wastewater improvements, and other

miscellaneous items necessary to complete the project in accordance with the plans and specifications.

Following are the locations and construction cost for each project:

If this project group is not awarded for construction at this time, the alleys will continue to deteriorate causing additional pavement cracking and potholes to form, creating additional maintenance cost for the City and potential damages to vehicles utilizing the alleys.
