BACKGROUND

This action will authorize a construction services contract with Estrada Concrete Company, LLC for the construction of two street reconstruction thoroughfare projects as Street Reconstruction Group 17 -4008.

The project group scope will include replacing the existing deteriorating streets with reinforced concrete pavement, curb, gutter, sidewalk, driveway approaches, drainage improvements, water and wastewater improvements, traffic signs and pavement markings, street illumination, and other

miscellaneous items necessary to complete the project in accordance with the intent of the plans and specifications.
