In addition, he has excellent working relationships with the leadership of key Congressional Committees that are important to the City.

On October 28, 2020, City Council authorized a contract with Paul Schlesinger for FY 2020-21, by Resolution No. 20-1705.

On October 13, 2021, City Council authorized a contract with Paul Schlesinger for FY 2021-22, by Resolution No. 21-1664.
