#### **BACKGROUND**

The BJA Gulf States Regional Law Enforcement Technology Assistance Initiative is an innovative new program designed to provide resources and technology to law enforcement jurisdictions within the five Gulf States (Florida, Alabama, Louisiana, Mississippi, and Texas) to assist with information and intelligence sharing to reduce crime and illegal drug trafficking. The grants awarded under this initiative are expected to enhance information and criminal intelligence sharing between local law enforcement agencies and their local fusion centers.

The City of Dallas Police Department's Dallas Fusion Center (DFC) will use the 2019 Gulf States Regional Law Enforcement Technology Assistance Initiative funding to enhance DFC, and therefore, surrounding jurisdictions with which DFC shares information.

DFC will use the grant funds to purchase a social media mapping service that uses advanced technology to extrapolate data across multiple social media platforms. By allowing analysts to quickly discern the social media communication patterns among suspects, the social media mapping service will help DFC to quickly identify social circles and gather intelligence on criminal enterprises where there once may have been only limited information on one or two suspects or incidents.
