BACKGROUND

Estrada Concrete Company, LLC is a Dallas-based corporation, operating within the corporate city limits of Dallas, Texas.

This action will authorize a construction contract with Estrada Concrete Company, LLC for the construction of six alley reconstruction projects as Alley Reconstruction Group 17-1202.

The project scope will include replacing the existing deteriorating alleys with reinforced concrete pavement and storm drainage improvements.

Field conditions may also change, which will require modifications to the engineering design plans, requiring additional funding and time to address.
