#### **BACKGROUND**

This action will authorize a construction contract with Camino Construction, L.P. for the construction of two street reconstruction projects as Street Reconstruction Group 17-8005.

The project scope will include replacing the existing deteriorating streets with reinforced concrete pavement, sidewalks, driveway approaches, storm drainage, and water and wastewater

If this project is not awarded for construction at this time, the roadways will continue to deteriorate causing additional pavement cracking and potholes to form, creating additional maintenance costs for the City and potential damages to vehicles utilizing the roadways. Field conditions may also change which will require modifications to the engineering design plans, requiring additional funding and time to address.
