Authorize a construction services contract for the construction of Street Reconstruction Group 17-1006 (list attached to the Agenda Information Sheet) - Estrada Concrete Company LLC, lowest responsible bidder of seven - Not to exceed \$1,518,259.00 - Financing: Street and Transportation (A) Fund (2017 General Obligation Bond Funds) (\$889,660.00), Water Utilities Capital Improvement D Fund (\$610,349.00), and Water Utilities Capital Construction Fund (\$18,250.00)

BACKGROUND

This action will authorize a construction services contract with Estrada Concrete Company, LLC for the construction of two street reconstruction projects as Street Reconstruction Group 17-1006.

The group scope will include replacing the existing deteriorating streets with reinforced concrete pavement, curb, gutter, sidewalks, driveways approaches, drainage system, and water improvements.
