BACKGROUND

This action will authorize a construction services contract with Estrada Concrete Company, LLC for the construction of six alley reconstruction projects as Alley Reconstruction Project Group 17-1403.

The project scope will include replacing the existing deteriorating concrete alleys with new reinforced concrete alley pavement, storm drainage, and water and wastewater improvements.
