<u>SUBJECT</u>

BACKGROUND

The Novel Coronavirus Disease 2019 ("COVID-19") pandemic and its resulting economic impacts have put thousands at risk of evictions and homelessness. Since Spring of 2020, the City has seen tremendous demand for rental assistance services, a demand which has continued, if not grown, as the pandemic continues. Though a combination of local and national moratoriums and other protections have helped some clients avoid eviction, the national level Centers for Disease Control moratorium is set to expire in early 2021.

This item authorizes acceptance of Community Development Block Grant funds from TDHCA for the implementation of the TDHCA's Texas Emergency Rental Assistance Program and Texas Eviction Diversion Program and the execution of necessary agreements with TDHCA and with subrecipients to enable program implementation.
