#### SUBJECT

Authorize the sale of **(1)** one 2015 Dodge Charger through a public auction ending on April 27, 2021 to Eric Guzman in the amount of \$23,500, highest bidder; and **(2)** one 2018 GMC Sierra pickup truck through a public auction ending on May 5, 2021 to Tindell Investments, LLC in the amount of \$41,500, highest bidder - Total Revenue: General Fund (\$55,250) and Express Business Center Fund (\$9,750)

#### **BACKGROUND**

This action seeks approval to sell one 2015 Dodge Charger to Eric Guzman in the amount of \$23,500, which was publicly auctioned ending on April 27, 2021 and one 2018 GMC Sierra pickup truck, which was publicly auctioned on May 5, 2021. These vehicles were a part of a normal auction of impounded vehicles from the Police Department's auto pound.

The City used its current contract auctioneer, Lone Star Auctioneers, Inc., to auction this vehicle. The auctioneer charges a buyer's premium instead of the city paying a fee.

Dallas City Code 2-37.4 requires that when the highest bid for property is more than \$20,000, the sale to the highest bidder must be confirmed by City Council.
