## **BACKGROUND**

The North Central Texas Council of Governments (NCTCOG) has received various Congestion Mitigation and Air Quality Improvement Program awards from the Federal Highway Administration through agreements executed with the Texas Department of Transportation (TxDOT), to fund subrecipient awards associated with the implementation of Traffic Signal Retiming During Incidents program.

NCTCOG will provide reimbursement to the City, a subrecipient, for implementation of Traffic Signal Retiming During Incidents, traffic monitoring equipment at 99 on-system intersections and 12 off-system intersections (outlined in Exhibit A), in the amount of \$630,982.00. Transportation and Development Credits are being used in lieu of local match. The City is responsible for any costs in excess of the award amount.
