Authorize a construction services contract for the construction of Alley Reconstruction Group 17-9001 - Package A (list attached to the Agenda Information Sheet) - Vescorp Construction, LLC dba Chavez Concrete Cutting, lowest responsible bidder of eight - Not to exceed \$975,051.40 - Financing: Street and Transportation (A) Fund (2017 General Obligation Bond Fund)

BACKGROUND

This action will authorize a construction services contract with Vescorp Construction, LLC dba Chavez Concrete Cutting for the construction of five alley reconstruction projects as Alley Reconstruction Project Group 17-9001 - Package A.

The project scope will include replacing the existing deteriorating concrete alleys with new reinforced concrete alley pavement, storm drainage improvements, and other miscellaneous items necessary to complete the project in accordance with the design plans and specifications.

Vescorp Construction, LLC dba Chavez Concrete Cutting is a registered vendor, and its office is

located in Balch Springs, Texas.
