### SUBJECT

Authorize (1) an extension to the current Office of Community Care (OCC) Energy Assistance Program; (2) the acceptance of donations from electric and energy providers in the amount of \$600,000.00, through the social services teams at the West Dallas Multipurpose Center and the Martin Luther King, Jr. Community Center, to provide temporary financial assistance to individuals and families who are experiencing a temporary financial crisis; and execution of agreements and any other necessary documents with electric and energy providers; (3) the receipt and deposit of funds in an amount not to exceed \$600,000.00 in the OCC Energy Assistance Fund - Estimated Revenue: \$600,000.00; (4) an increase in appropriations in an amount not to exceed \$600,000.00 in the OCC Energy Assistance Fund; and (5) execution of agreement and any other necessary documents with electric and energy providers - Not to exceed \$600,000.00 - Financing: OCC Energy Assistance Fund

## **BACKGROUND**

OCC provides utility assistance to individuals and families who are experiencing a temporary financial crisis. The assistance provides relief to those households most vulnerable to the high cost of energy for home heating and cooling. Customers experiencing difficulty in paying utility bills have an option to reach out to our social services department for assistance.

### **How the Program Works**

- 1 City receives donations from multiple electric and energy providers to provide utility assistance
- 2 OCC qualifies clients based on the funder's established eligibility standards
- 3 OCC makes pledge on behalf of client
- 4 City remits payment to utility company with supporting documentation that denotes payment
- 5 Payment should be remitted within 30-45 days from the pledge date
- 6 OCC sends utility assistance funder a report at a frequency identified by funder via email recording activity and balance of funds

## **PRIOR ACTION/REVIEW (COUNCIL, BOARDS, COMMISSIONS)**

On August 14, 2019, City Council authorized acceptance of donations from electric and energy providers in the amount of \$500,000.00, through the social services teams at the West Dallas Multipurpose Center and the Martin Luther King, Jr. Community Center to provide temporary financial assistance to individuals and families who were experiencing a temporary financial crisis for the period August 30, 2019 through September 30, 2020, by Resolution No. 19-1111.
