#### **BACKGROUND**

This action will authorize a construction services contract with Estrada Concrete Company, LLC for the construction of two street reconstruction projects as Street Reconstruction Group 17-1020.

The project group scope will include street paving, curb and gutters, driveway approaches, storm

drainage improvements, and water and wastewater improvements.
