BACKGROUND

The ASTC is a Maryland non-profit corporation. In partnership with the Institute of Museum and

Library Science, ASTC created the Communities for Immunity initiative to provide funding for libraries and museums across the United States to conduct COVID-19 vaccine outreach to vaccine hesitant populations The City of Dallas, Dallas Public Library, has been awarded one of these grants.

The Communities for Immunity Grant will enable Dallas Public Library to conduct vaccine outreach and education to zip codes in the Dallas area which have the lowest COVID-19 vaccination rates. Funding provided by this grant will support the purchasing of educational materials, including yard signs and bookmarks, to inform residents in select zip codes about vaccinations. Information will include facts on the effectiveness and safety of vaccines, why vaccination is important, and how to obtain a vaccine.
