BACKGROUND

This action will authorize a Project Specific Agreement with Dallas County to identify and fund

qualified various "Type B" public roadways within the City of Dallas.

This project will consist of transportation-related maintenance, repairs, and improvements of Haskell Avenue (North of Interstate Highway-30 [IH-30]) from Weldon Street to IH-30; Haskell Avenue (South of IH-30) from IH-30 to East Grand Avenue, Skillman Street from Northwest Highway to Abrams Road; Gaston Avenue from Peak Street to Ridgeway Street; Wycliff Avenue from Lemmon Avenue to Highland Park City Limits (Oak Lawn Avenue); Sam Houston Road from St. Augustine Drive to Military Parkway.

The City of Dallas is the lead agency responsible for administering construction of the abovementioned projects to be performed by City contractors.

The total estimated project cost for construction is \$9,697,480.00 of which \$4,848,740.00 is to be funded by Dallas County and \$4,848,740.00 is to be funded by the City of Dallas.
