## **BACKGROUND**

This action does not encumber funds; the purpose of a master agreement is to establish firm pricing for goods, for a specific term, which are ordered on an as needed basis according to annual budgetary appropriations. The estimated amount is intended as guidance rather than a cap on spending under the agreement, so that actual need combined with the amount budgeted will determine the amount spent under this agreement.

This master agreement will provide for the purchase of various types of herbicides and pesticides for use by City staff to protect existing City green spaces. Herbicides destroy or inhibit unwanted vegetation growth and weeds; pesticides inhibit invasive insects. Bid product line items containing chemicals of concern including Glyphosate and Neonicotinoids from the previous solicitation that went to City Council for approval on January 8, 2020, have been removed and substituted with green organic alternative products. The master agreement will be used throughout the City, including over 23,000 acres of Park & Recreation Department property which includes six 18-hole golf courses and over 200 athletic fields. The items purchased from this master agreement will also be used at Water Utilities Department facilities and work sites, as well as the City's roadway medians.

As part of the solicitation process and in an effort to increase competition, the Office of Procurement Services used its procurement system to send out email notifications to vendors registered under relevant commodity codes. To further increase competition, the Office of Procurement Services uses historical solicitation information, the Internet, and vendor contact information obtained from user departments to contact additional vendors.
