BACKGROUND

This action does not encumber funds; the purpose of a service price agreement is to establish firm pricing for services, for a specific term, which are ordered on an as needed basis according to annual budgetary appropriations. The estimated amount is intended as guidance rather than a cap on spending under the agreement, so that actual need combined with the amount budgeted will determine the amount spent under this agreement.

This service contract will be used to purchase original equipment manufacturer and aftermarket parts

and labor. The City has approximately 8,500 pieces of equipment ranging from light and heavy-duty trucks to excavators. This service contract will be used to supplement the City's need for factory authorized service repairs to City vehicles and equipment necessary to keep the equipment in good, reliable condition. This contract also includes parts and labor for vehicles and equipment in support of the additional areas such as landfill, airport, and water operations.

Departments will manage the vendor utilization according to specialization, demand and capacity of each vendor for each service required through project specific work orders.

A six-member committee from the following departments reviewed and evaluated the qualifications:

•	Department of Equipment and Fleet Management	(2)
•	Department of Sanitation Services	(1)
•	Police Department (1)	
•	Water Utilities Department	(1)
•	Office of Procurement Services	(1)*

*The Office of Procurement Services only evaluated cost, and local Preference, if applicable.

The committee selected the successful respondent on the basis of demonstrated competence and qualifications under the following criteria:

٠	Cost	50 points
•	Capabilities and expertise	45 points
•	Local Preference	5 points

As part of the solicitation process and in an effort to increase competition, the Office of Procurement Services used its procurement system to send out email notifications to vendors registered under relevant commodity codes. To further increase competition, the Office of Procurement Services uses historical solicitation information, the Internet, and vendor contact information obtained from user departments to contact additional vendors.

On November 10, 2015, the City Council authorized a living wage policy that requires contractors to pay their employees a "living wage" rate as established annually by the Massachusetts Institute of Technology Living Wage Calculator for Dallas County by Resolution No. 15-2141. The current calculated living wage during the solicitation process of this contract is \$15.21; the selected vendors meet this requirement.
