Diesel North Texas 2021 Fund; **(4)** a required local match in the amount of \$1,441,045.00 from Sanitation Equipment Acquisition Notes Fund; and **(5)** execution of the grant agreement and all terms, conditions, and documents required by the grant agreement - Not to exceed \$2,216,995.00 - Financing: North Central Texas Council of Governments Grant Funds (\$775,950.00) and 2021 Equipment Acquisition Notes Fund (\$1,441,045.00)

BACKGROUND

In April 2022, the Department of Equipment and Fleet Management applied for funding under the Clean Diesel North Texas 2021 Call for Projects from the North Central Texas Council of Governments. This \$775,950.00 grant award represents partial funding for five replacement vehicles for the City of Dallas that will be assigned to Sanitation Services. These five vehicles include projects/activities for five automated side loader refuse trucks. The award funds approximately 35 percent of the cost of a replacement vehicle or equipment. The remaining funds are matched through the Sanitation Equipment Acquisition Notes Fund.
