Authorize a personal services contract with Randy C. Cain for state legislative and information services for the period November 1, 2022 through September 30, 2023 - Not to exceed \$71,000.00 - Financing: General Fund (subject to annual appropriations)

#### BACKGROUND

Randy C. Cain operates an Austin office which monitors state action affecting governmental entities and corporations before the State Legislature. The scope of services for this contract will include:

- Representation before state agencies and legislators.
- Monitoring interim state legislative and committee activities as requested by the City Council, City Manager and City Attorney.
- Assistance with special projects as requested.

## PRIOR ACTION/REVIEW (COUNCIL, BOARDS, COMMISSIONS)

On December 9, 2020, City Council authorized a contract with Randy C. Cain for FY 2020-21, by Resolution No. 20-1933.

On October 13, 2021, City Council authorized a contract with Randy C. Cain for FY 2021-22, by Resolution No. 21-1667.

The Ad Hoc Committee on Legislative Affairs was briefed by memorandum regarding this matter on September 13, 2022.
