SUBJECT

Authorize a five-year service price agreement for industrial, commercial, and institutional water assessments for the Office of Environmental Quality and Sustainability - Alan Plummer and Associates, Inc. dba Plummer Associates, Inc., only bidder - Estimated amount of \$971,220 - Financing: General Fund (subject to annual appropriations)

BACKGROUND

This action does not encumber funds; the purpose of a service price agreement is to establish firm pricing for services, for a specific term, which are ordered on an as needed basis according to annual budgetary appropriations. The estimated amount is intended as guidance rather than a cap on spending under the agreement, so that actual need combined with the amount budgeted will determine the amount spent under this agreement.

This service price agreement will provide for industrial, commercial, and institutional (ICI) water assessments for the Office of Environmental Quality and Sustainability. ICI water consumption audits assist customers by helping them identify potential water savings throughout their facilities. ICI water

consumption audits are included as a water conservation strategy in the City's 2016 water conservation five-year work plan (Plan).

The Plan targets a reduction in gallons per capita per day by an average 1.0 percent per year. A major emphasis has been placed on efforts to aid ICI customers realize their full potential for water savings and increased efficiency. To that end, professional water assessments are offered free of charge to the ICI water customers. These customers represent approximately 59 percent of all retail water use. The City's goal is to have the awarded contractor perform approximately 150 building assessments annually. The contract also provides for follow-up inspections and verification of completed water conservation rebate projects.

The rebate will serve to complement and enhance the ICI assessment initiative. By providing financial incentives that encourage large ICI water users to install new water efficient equipment, the City will help lower the cost of water efficiency investments and accelerate large volumes of water savings among high water-using customers.

In the last five years, the program has performed approximately 769 building water assessments for 69 ICI customers and has awarded 12 rebates with average water savings of approximately 73 million gallons per year.

Customers participating in the ICI Rebate Program will be required to sign an agreement with the City that specifies the rebate amount, installation deadline, and other conditions to ensure that the expected water savings are achieved and maintained after the rebate has been paid. The rebate for each project shall be the lesser of half the combined cost of the purchase price of the equipment and the cost of the contracted labor to install the equipment, or the amount determined by calculating total savings in thousand gallons increments over the life of the project and multiplying that amount by the allowable cost per 1,000 gallons of water saved. The allowable cost per 1,000 gallons of water saved may be adjusted annually depending upon the true cost of regional water supplies. The maximum rebate for any given project is \$100,000. Rebates for more than \$25,000 require approval from the City Council.

As part of the solicitation process and in an effort to increase competition, the Office of Procurement Services used its procurement system to send out email notifications to vendors registered under relevant commodity codes. To further increase competition, the Office of Procurement Services uses historical solicitation information, the Internet, and vendor contact information obtained from user departments to contact additional vendors.

On November 10, 2015, the City Council authorized a living wage policy that requires contractors to pay their employees a "living wage" rate as established annually by the Massachusetts Institute of Technology Living Wage Calculator for Dallas County by Resolution No. 15-2141. The calculated living wage during the solicitation process of this contract is \$17.82; the selected vendor meets this requirement.

PRIOR ACTION/REVIEW (COUNCIL, BOARDS, COMMISSIONS)

On November 8, 2017, City Council authorized a five-year service contract for a water consumption rebate program for industrial, commercial, and institutional facilities with Alan Plummer and Associates, Inc. by Resolution No. 17-1742.
