BACKGROUND

This action will authorize a construction services contract with Estrada Concrete Co., LLC, for the construction of three street reconstruction projects as Street Reconstruction Group 17-1410.

The scope of the project group will include replacing the existing deteriorating streets with new reinforced concrete pavement, curb, gutter, sidewalk, driveway approaches, pavement marking,

storm drainage, water and wastewater improvements and other miscellaneous items necessary to complete the project in accordance with the plans and specifications.

Estrada Concrete Co., LLC is a Hutchins-based corporation, operating within the corporate city limits of Hutchins, Texas.

If this project group is not awarded for construction at this time, the streets will continue to deteriorate causing additional pavement cracking and potholes to form, creating additional maintenance costs for the City and potential damages to vehicles utilizing the streets. Field conditions may also change, which will require modifications to the engineering design plans, requiring additional funding and time to address.
