BACKGROUND

On November 1, 2021, the City of Dallas executed an Advance Funding Agreement (AFA) for the SS 366 (Woodall Rodgers Freeway) Deck Plaza Structure Extension project with the Texas Department of Transportation for the design and construction of the extension to the west of the deck plaza of the existing Klyde Warren Park. The total estimated project cost is \$65,383,008 funded as follows: Federal participation-\$36,800,000, State participation-\$8,743,008, and City (Local) participation-\$19,840,000. The City is responsible for the Local participation in the WRF2 Project.

Dallas County desires to enter into a Project Specific Agreement (PSA) with the City to provide funding \$1,350,900.00, inclusive of Dallas County administrative costs in accordance with the Master Agreement with the City.

Dallas County agrees to participate in the project as a funding participant, to attend task force and field construction meetings, and to review, comment, and approve or accept work performed by the City, its contractors and subcontractors.

Execution of this agreement does not change the estimated project schedule.
