#### **SUBJECT**

#### **BACKGROUND**

This action does not encumber funds; the purpose of a service price agreement is to establish firm pricing for services, for a specific term, which are ordered on an as needed basis.

This Supplemental Agreement will provide for continued citywide repair, maintenance, parts, and labor of overhead doors on City owned buildings. This service price agreement is necessary to

ensure gates and overhead doors in City facilities are in good working condition to safeguard buildings from unauthorized access during non-operation hours and to ensure the safety of staff during daily operations.

Approximately 600 overhead doors secure various City facilities, including fire stations, training facilities, workshops, warehouses, service centers, and other facilities. These doors range in size from eight to 29 feet high and eight to 24 feet wide and are constructed of metal, wood, and/or glass panels.

On November 10, 2015, the City Council authorized a living wage policy that requires contractors to pay their employees a "living wage" rate as established annually by the Massachusetts Institute of Technology Living Wage Calculator for Dallas County by Resolution No. 15-2141. This contract renewal option includes the most current living wage of \$17.82.

#### PRIOR ACTION/REVIEW (COUNCIL, BOARDS, COMMISSIONS)

On December 12, 2018, the City Council authorized a three-year service price agreement for citywide overhead door repair, maintenance, parts, and labor with Miner Ltd. dba Overhead Door Co. of Dallas by Resolution No. 18-1799.
