**BACKGROUND**

This item authorizes an increase in the purchase amount of a wastewater easement from Berkeley Industries Ltd., containing approximately 955 square feet of land located near Arapaho and Preston Roads for the McKamy and Osage Branch Wastewater Interceptor Project. This property will be used for improvements and relocation of the McKamy and Osage Branch wastewater line. The consideration is based on an independent appraisal.

There are no relocation benefits.

On June 26, 2019, the City Council authorized acquisition from Berkeley Industries Ltd., of approximately 955 square feet of land located near Arapaho and Preston Roads for the McKamy and Osage Branch Wastewater Interceptor Project by Resolution No. 19-0990.
