<u>SUBJECT</u>

Authorize Supplemental Agreement No. 2 to the design-build contract with Harrison Walker & Harper, LLC to provide construction services for the new Fire Station No. 59 facility to be located at 201 North Jim Miller Road - Not to exceed \$200,169.54, from \$6,578,434.00 to \$6,778,603.54 - Financing: Public Safety (G) Fund (2017 General Obligation Bond Fund)

BACKGROUND

On May 8, 2019, Harrison Walker & Harper, LLC., was awarded the design-build services contract of the new Fire Station No. 59 facility to be located at 201 North Jim Miller Road.

This action will authorize an increase to the design-build contract with Harrison Walker & Harper, LLC. For the installation of the radio alerting system and additional design services for this facility.

Deferral of this item would delay the project's completion date, which will negatively impact response times for the Fire Station No. 59 service area. Fire Station No. 59 provides crucial fire and rescue services to the citizens of Dallas. The new facility is currently expected to open in September 2021.

On April 22, 2020, City Council authorized a Supplemental Agreement No. 1 to the design-build services contract with Harrison Walker & Harper, LLC. to provide construction services for the new Fire Station No. 59 facility by Resolution No. 20-0611.
