COMMENCING at a 1/2 inch iron pipe found for corner, said corner being along the West right of way line of Los Angeles Boulevard (60 foot right of way), by Map recorded in Volume 5, Page 434, of Map Records, Dallas County, Texas, same being the Southeast corner of Lot 11-D, Block 6961, of said Larr Subdivision of Oak Cliff Ranches Addition, same being the Northeast corner of a tract of land conveyed to Pearlle Dotson & Spouse Joe Dotson, by Warranty Deed recorded in Volume 2000100, Page 3175, Deed Records, Dallas County, Texas;

THENCE South 88 degrees 51 minutes 09 seconds West, along the North line of said Dotson tract, a distance of 143.00 feet to a 1/2 inch iron rod found for corner, said corner being a Northeast corner of Lot 2, Block A/6961, Ed H. Miller Addition, an Addition to the City of Dallas, according to the Plat recorded in Volume 96107, Page 498, of Map Records, Dallas County, Texas and being the POINT OF BEGINNING of herein tract described;

THENCE South 88 degrees 51 minutes 09 seconds West, along the North line of said Lot 2, a distance of 15.00 feet to a point for corner, said corner being a Southeast corner of said Lot 11-C, Block 6961 of said Larr Subdivision of Oak Cliff Ranches Addition;

THENCE North 01 degrees 08 minutes 51 seconds West, along a East line of said Lot 11-C, a distance of 107.00 feet to a point for corner;

THENCE North 88 degrees 51 minutes 09 seconds East, along a South line of said Lot 11-C, a distance of 15.00 feet to a point for corner, said corner being in the Northwest corner of said Lot 11-D;

THENCE South 01 degrees 08 minutes 51 seconds East along the West line of said Lot 11-D, a distance of 107.00 feet to the Point of Beginning and containing 1,605 square feet and/or 0.037 acres of land.

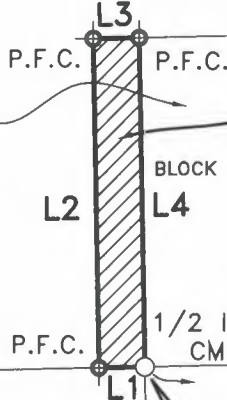

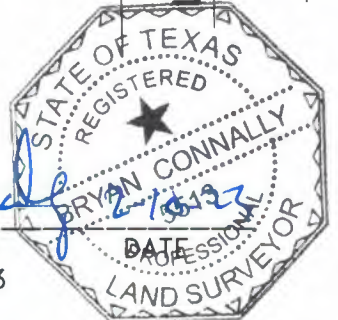
