REQUEST: An application for a new Specific Use Permit for a private recreation center, club, or area on property zoned Planned Development District No. 206.

SUMMARY: The purpose of the request is to allow recreation center within an existing building of the existing retirement housing community.

STAFF RECOMMENDATION: **Approval**, subject to a site plan and conditions.

CPC RECOMMENDATION: **Approval** for a five-year period, subject to a site plan and conditions.

BACKGROUND INFORMATION:

- The area of request is currently zoned Planned Development District 206, the Meadowstone Place Stone Canyon, and is developed with a condominium.
- The surrounding area is predominantly single family and condominium, with commercial and hotels nearby.
- The applicant wishes to use an existing portion of building on the site for a recreation center. As such, they request a Specific Use Permit as shown on the site plan.

Zoning History:

There have been no zoning cases in the area within the last five years.

Traffic:

The Transportation Development Services Division of the Transportation Department has reviewed the request and determined that it will not significantly impact the surrounding roadway system. Staff will continue review of engineering plans at permitting to comply with city standards.

STAFF ANALYSIS:

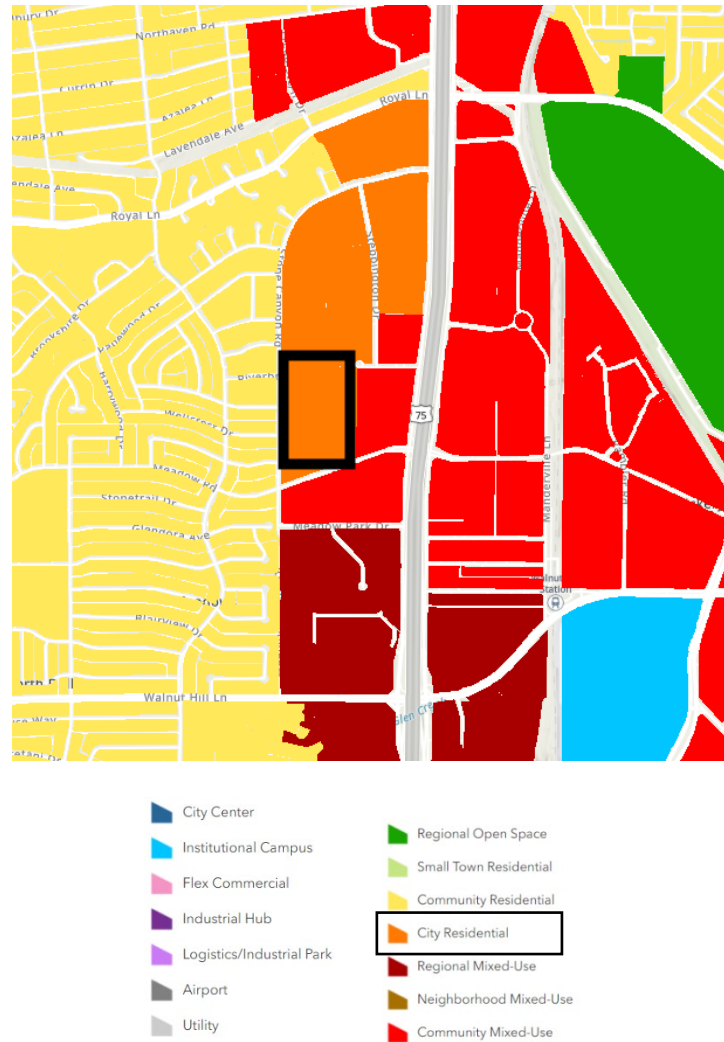
Comprehensive Plan:

ForwardDallas 2.0 is the citywide Comprehensive Plan for future land use in the City of Dallas. Adopted by City Council in September 2024, the plan includes a future land use map and guidance for a future vision of the City of Dallas. It also establishes goals and guidelines for land use and other decisions by the City. According to the City of Dallas's Development Code, the comprehensive plan serves merely as a guide for rezoning requests but does not establish zoning boundaries nor does it restrict the City's authority to regulate land use.

The proposed specific use permit is generally **consistent** with Forward Dallas 2.0. Private Open Space is a secondary land use in the City Residential placetype. The subject property is located on a community collector, Meadow Road. It is located on a corner lot between Stone Canyon Road and Meadow Road, and adjacent to an existing condominium. The property appears to be currently used as a condominium.

The design recommendations in Forward Dallas 2.0 are applicable in this case, but this SUP provides only limited review of the consistency with those recommendations. In this placetype, for this future land use, Forward Dallas 2.0 recommends that the design be sensitive to the context of the community and that include community engagement should occur early on and be given significant weight in decision making.

The map below illustrates the site's location within the forwardDallas 2.0 placetype framework.



Placetype Summary

Placetypes describe the long-term vision and desired building and preservation characteristics for different places within the city including neighborhoods, mixed-use areas, employment and industry centers, and open spaces. They provide a high-level guide for the desired mix of land uses, design and the recommended intensity and scale of the different uses. Due to the macro scale of the plan, not all uses or design considerations described within the placetypes may be suitable for every individual property.

The City Residential placetype provides the greatest variety of housing types among all of the residential placetypes. City Residential neighborhoods primarily consist of high and mid-rise multifamily development, complemented by townhomes and duplex housing. For

City Residential areas surrounding Downtown Dallas, development is concentrated in compact blocks with quality access to transit and a high degree of connectivity to surrounding neighborhoods. Mixed-use buildings in urban areas, generally developed vertically (multiple uses in a single building), also offer retail and commercial amenities along fixed transit/ transportation nodes, hubs, and corridors.

Land Use Compatibility:

The request site is currently developed with a condominium. The applicant proposes to utilize the existing site as a recreation center. The immediate surroundings of the site are predominantly condominium and single-family houses, with commercial and hotels to the east of the site.

The general provisions for a Specific Use Permit in Section 51A-4.219 of the Dallas Development Code specifically state: (1) The SUP provides a means for developing certain uses in a manner in which the specific use will be consistent with the character of the neighborhood; (2) Each SUP application must be evaluated as to its probable effect on the adjacent property and the community welfare and may be approved or denied as the findings indicate appropriate; (3) The city council shall not grant an SUP for a use except upon a finding that the use will: (A) complement or be compatible with the surrounding uses and community facilities; (B) contribute to, enhance, or promote the welfare of the area of request and adjacent properties; (C) not be detrimental to the public health, safety, or general welfare; and (D) conform in all other respects to all applicable zoning regulations and standards. The regulations in this chapter have been established in accordance with a comprehensive plan for the purpose of promoting the health, safety, morals, and general welfare of the city.

Staff supports the requested Specific Use Permit, as the subject site is located at the corner of Stone Canyon Road and Meadow Road along a designated community collector. The proposed recreation center is not expected to interfere with surrounding residential uses or negatively impact existing traffic conditions. The site plan limits both the size and the location of the facility to the center of the site, which is not visible from the roadway. The recreation center will be a valuable addition to the community and will greatly serve the residents of Meadowstone Place.

Development Standards

Following is a table showing the development standards of the current Planned Development 206.

Landscaping:

According to PD 206, Landscaping must be provided as shown on the landscape plan (Exhibit 206B). If there is a conflict between the text of the PD and the landscape plan, the PD controls. Plant materials must be maintained in a healthy, growing condition. All landscaped areas must be fully sprinkled.

Parking:

Parking must be provided in accordance with the Dallas Development Code. According to the Parking Reform Amendment:

- Tiered parking ratio:
 - Developments 200 dwelling units or more: Minimum 1 space per dwelling unit.
 - Developments between 21 and 199 dwelling units: Minimum 1/2 space per dwelling unit.
 - Developments 20 dwelling units and less: No minimum parking required.
- Tiered guest parking requirement clearly marked at the entrance:
 - Developments 100 dwelling units and more: 15% of the required must be reserved for guests.
 - Developments between 21 and 99 dwelling units: 10% of the required must be reserved for guests.

Market Value Analysis:

Market Value Analysis (MVA), is a tool to aid residents and policy-makers in understanding the elements of their local residential real estate markets. It is an objective, data-driven tool built on local administrative data and validated with local experts. The analysis was prepared for the City of Dallas by The Reinvestment Fund. Public officials and private actors can use the MVA to more precisely target intervention strategies in weak markets and support sustainable growth in stronger markets. The MVA identifies nine market types (A through I) on a spectrum of residential market strength or weakness. As illustrated in the attached MVA map, the colors range from purple representing the strongest markets (A through C) to orange, representing the weakest markets (G through I). The area of request is within an "I" MVA area.

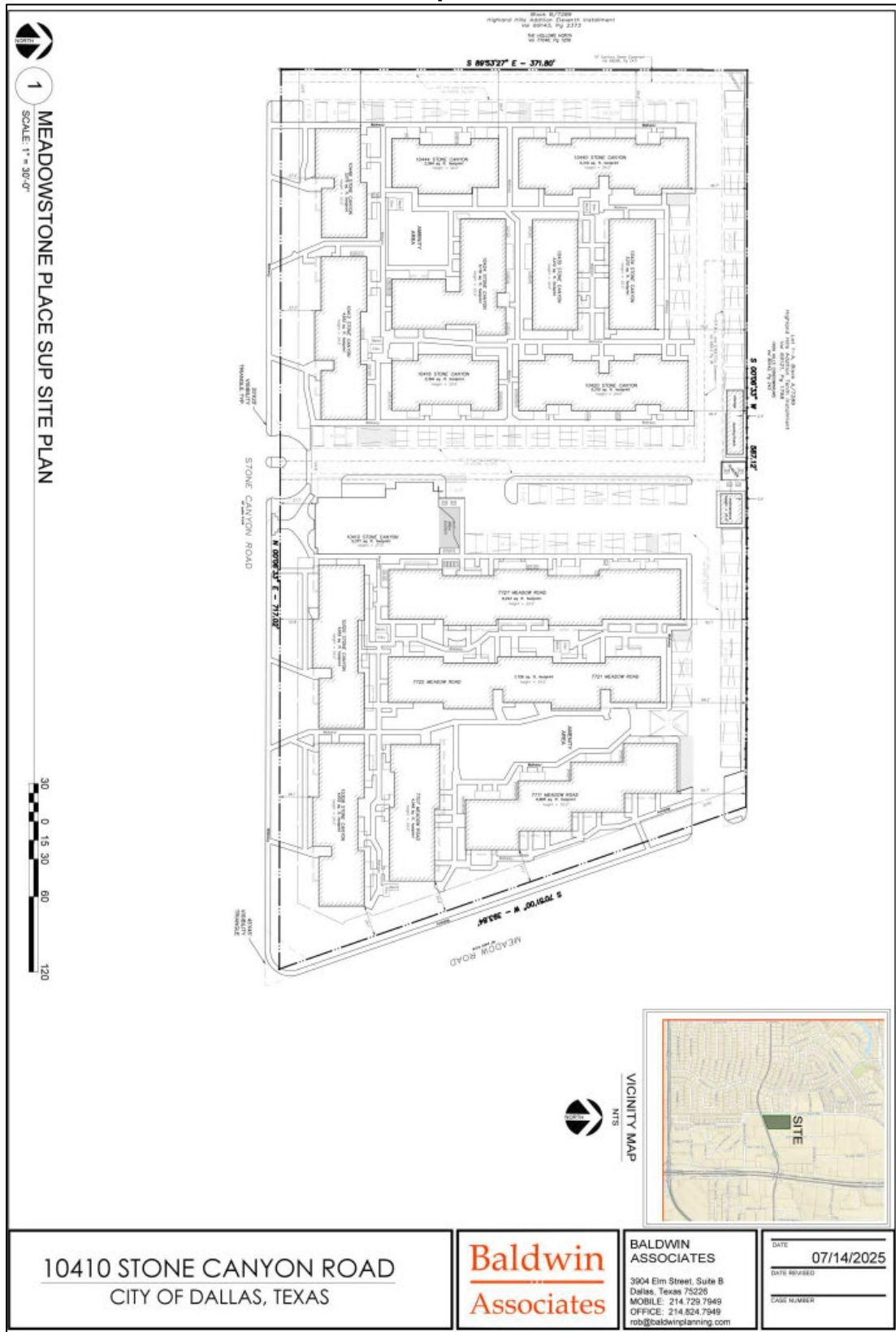

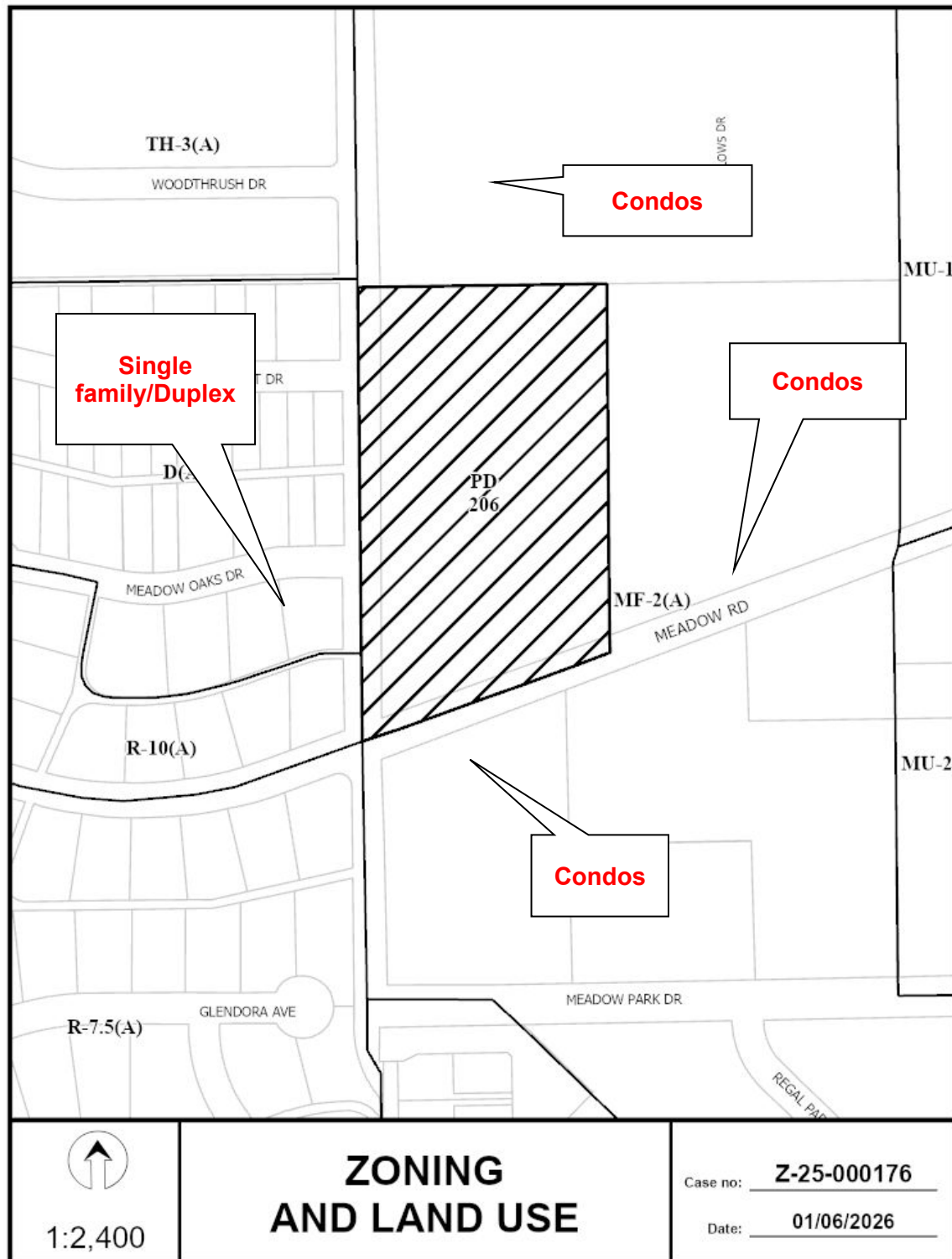
Proposed Site Plan

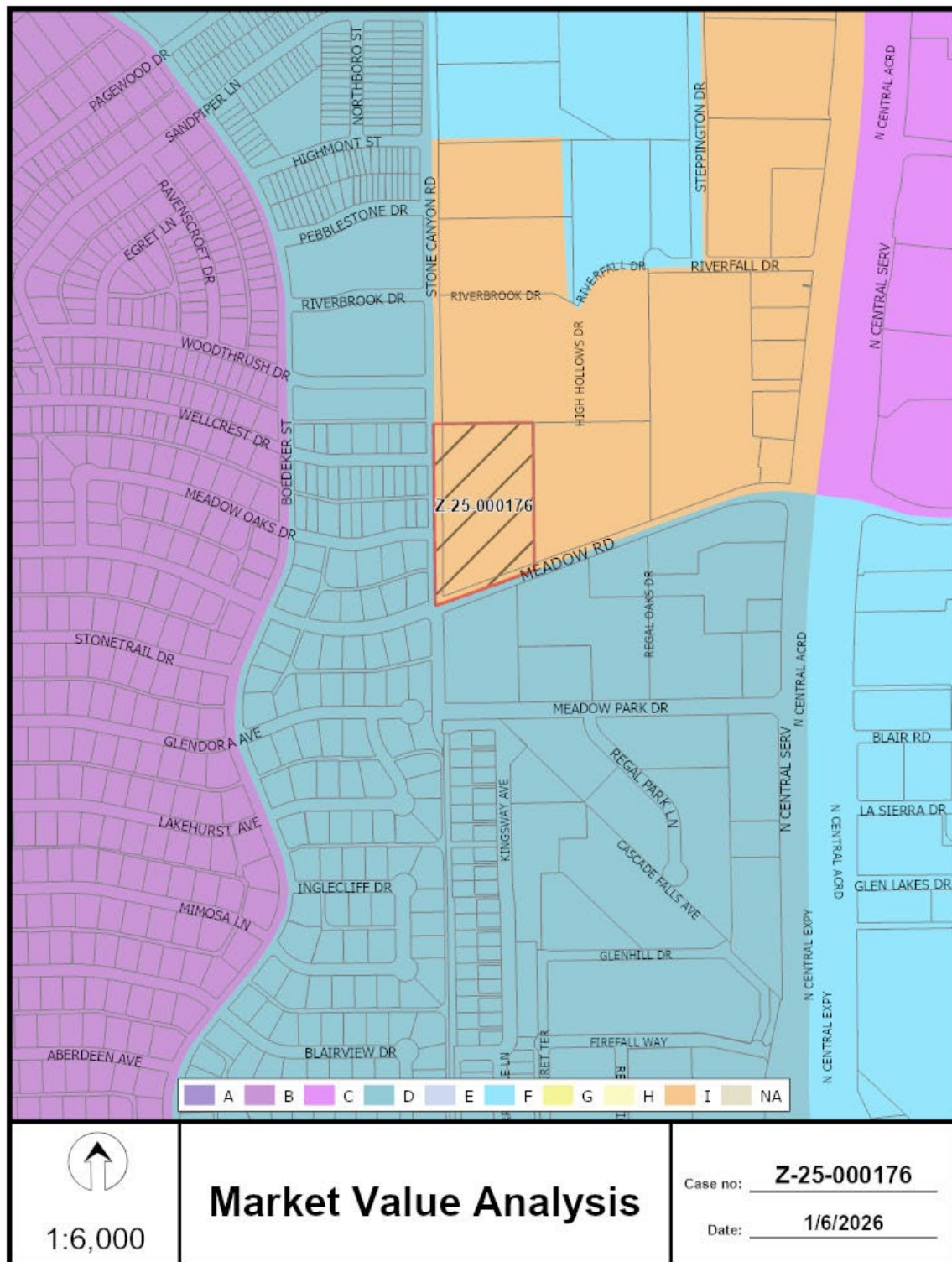


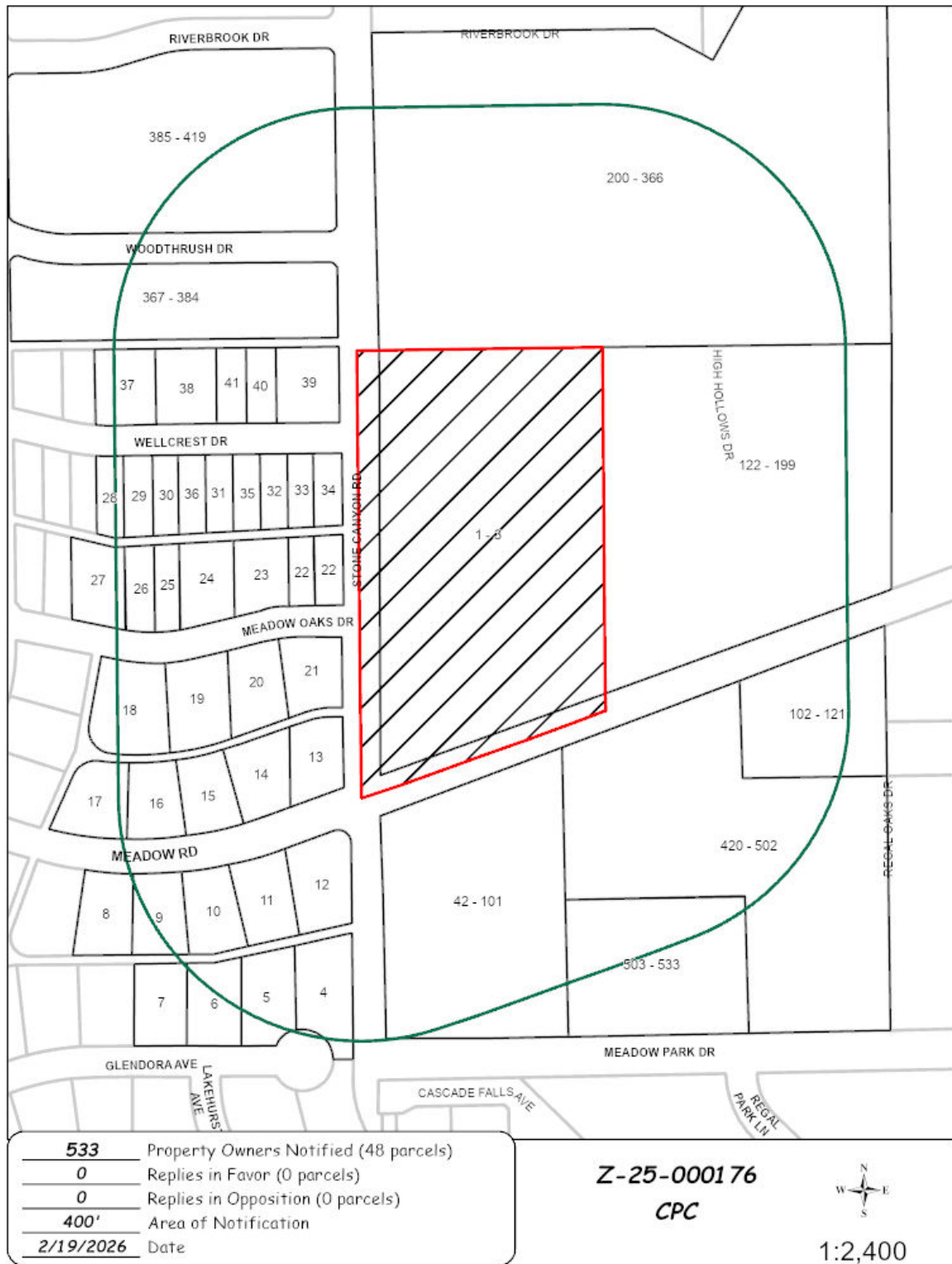
Proposed SUP Conditions

1. USE: The only use authorized by this specific use permit is a private recreation center, club, or area.
2. SITE PLAN: Use and development of the Property must comply with the attached site plan.
3. TIME LIMIT: This specific use permit expires on _____. (5-years after passage.).
4. FLOOR AREA: The maximum floor area for the private recreation center, club, or area is 1,700 square feet in the location shown on the attached site plan.
5. HOURS OF OPERATION: The private recreation center, club, or area may only operate between 9:00 a.m. and 12:00 a.m. (midnight), Monday through Sunday.
6. PARKING: Parking must be provided in accordance with the requirements of Planned Development District No. 206.
7. MAINTENANCE: The Property must be properly maintained in a state of good repair and neat appearance.
8. GENERAL REQUIREMENTS: Use of the Property must comply with all federal and state laws and regulations, and with all ordinances, rules, and regulations of the City of Dallas.
