**WHEREAS**, the U.S. Department of Homeland Security (DHS), Federal Emergency Management Agency (FEMA) has awarded funding under the 2026 FIFA World Cup Grant Program (FWCGP) activities for the 2026 FIFA World Cup; and

**WHEREAS**, under the grant program requirements, such funding is awarded to an eligible governmental entity that serves as the fiduciary and fiscal agency for grant funds, with the responsibility for financial administration, compliance, and reporting; and

**WHEREAS**, the North Central Texas Council of Governments (NCTCOG), in coordination with the North Texas FWC Organizing Committee (NTFWCOC), was named as the fiduciary and fiscal agent for the FWCGP; and

**WHEREAS**, on March 26, 2026, the Executive Board, authorized participation in a project awarded by the DHS, FEMA for NCTCOG to serve as the fiscal agent of grant funds and issue subawards; and

**WHEREAS**, NCTCOG will serve as the fiscal agent and pass-through entity for the FWCGP, the NTFWCOC in collaboration with the FIFA Host City Task Force retains programmatic oversight and approval authority over eligible activities and the use of grant funds in accordance with FIFA and federal grant requirement; and

**WHEREAS**, the City of Dallas, a Governing Body in the NCTCOG region, pursuant to laws of the State of Texas, was awarded a subaward under the 2026 FIFA World Cup grant program; and

**WHEREAS**, the Interlocal Cooperation Act, Chapter 791 of the Texas Government Code, provides authority for the North Central Texas Council of Governments and Local Governments to enter into this Agreement for the provision of governmental functions and services of mutual interest.

**Now, Therefore,**

**BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF DALLAS:**

**SECTION 1.** That the City Manager is hereby authorized to execute the Interlocal Agreement with NCTCOG, approved as to form by the City Attorney, designating the City of Dallas as a subrecipient for reimbursable activities through the 2026 FIFA World Cup Grant Program.

**SECTION 2.** That the City Manager is hereby authorized to establish appropriations in an amount not to exceed \$24,581,327.21 in the NCTCOG FIFA World Cup Grant Program Fund, Fund F826, Department MGT, Various Units, Object 3099.

**SECTION 3.** That the Chief Financial Officer is hereby authorized to receive and deposit funds in an amount not to exceed \$24,581,327.21 in the NCTCOG FIFA World Cup Grant Program Fund, Fund F826, Department MGT, Various Units, Revenue Code 6506.

**SECTION 4.** That the Chief Financial Officer is hereby authorized to disburse funds in an amount not to exceed \$24,581,327.21 in the NCTCOG FIFA World Cup Grant Program Fund, Fund F826, Department MGT, Various Units, Object 3099.

**SECTION 5.** That this contract is designated as Contract No. ECR-2026-00030564.

**SECTION 6.** That this resolution shall take effect immediately from and after its passage in accordance with the provisions of the Charter of the City of Dallas, and it is accordingly so resolved.
