WHEREAS, the Texas Legislature has approved the Parks and Wildlife Code, Section 24.005 for allowing the political subdivisions of the State of Texas to participate in the Texas Recreation and Parks Account Program; and

WHEREAS, the City of Dallas is fully eligible to receive assistance under the Target Range Planning Grant of the Texas Park and Wildlife Department; and

WHEREAS, the Texas Parks and Wildlife Department has made available and offered state financial aid monies for the purposed of funding the planning and design of an archery range at Samuell Farm (East); and

WHEREAS, the applicant is desirous of authorizing an official to represent and act for the applicant in dealing with the Texas Parks and Wildlife Department concerning this program.

Now, Therefore,

BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF DALLAS:

SECTION 1. That the City of Dallas, Texas hereby certifies that it is eligible to receive assistance under these programs, and that notice of the application will be posted according to local public hearing requirements.

SECTION 2. That the City Manager is hereby authorized to apply for and accept a grant from the U.S. Fish and Wildlife Service (FWS) through the Texas Parks and Wildlife Department (TPWD) for the Dallas Park & Recreation Samuell Farm Archery Project (Grant No. WR-TX W-25101, Federal Award Identification No. F25AF02663, Assistance Listing No. 15.611) in the amount of \$225,500.00 (Federal \$200,250.00), (City cost share \$22,250.00) for the planning and design of an archery range at Samuell (East) Farm located at 100 US-80 for the period August 1, 2025 to June 30, 2028; and execute the grant agreement with TPWD and all terms, conditions, and documents required by the agreement, approved as to form by the City Attorney.

SECTION 3. That the City Manager is hereby authorized to establish appropriations in an amount not to exceed \$200,250.00 in the TPWD Samuell Farm Archery Planning Design Grant Fund, Fund F823, Department PKR, Unit 685P, Object 4112.

SECTION 4. That the Chief Financial Officer is hereby authorized to receive and deposit funds in an amount not to exceed \$200,250.00 in the TPWD Samuell Farm Archery Planning Design Grant Fund, Fund F823, Department PKR, Unit 685P, Revenue Code 6506.

SECTION 5. That the Chief Financial Officer is hereby authorized to disburse funds in an amount not to exceed \$200,250.00 in the TPWD Samuell Farm Archery Planning Design Grant Fund, Fund F823, Department PKR, Unit 685P, Object 4112, Program F823685P, Encumbrance/Contract No. PKR-2026-00030276.

SECTION 6. That the Chief Financial Officer is hereby authorized to disburse funds in an amount not to exceed \$22,250.00 in the Samuell Park Exp. Trust Fund, Fund 0330, Department PKR, Unit 6975, Object 4112, Program 03306975, Encumbrance/Contract No. PKR-2026-00030276.

SECTION 7. That the City Manager is hereby authorized to reimburse to the granting agency any expenditures identified as ineligible. The City Manager shall notify the appropriate City Council Committee of expenditures identified as ineligible no later than 30 days after the reimbursement.

SECTION 8. That the City of Dallas, Texas hereby authorizes and directs the Dallas Park & Recreation Department (DPARD) to act for the City of Dallas in dealing with the Texas Parks and Wildlife Department for the purposes of the program, and that the Director of the DPARD or his or her designee is hereby officially designated as the representative in this regard.

SECTION 9. That the City of Dallas, Texas hereby specifically authorizes the DPARD to make application to the Texas Parks and Wildlife Department concerning the project known as the Dallas Park & Recreation Department Samuell Farm Archery Project.

SECTION 10. That the City Manager shall keep the appropriate City Council Committee informed of all final granting agency monitoring reports not later than 30 days after the receipt of the report.

SECTION 11. That this resolution shall take effect immediately from and after its passage in accordance with the provisions of the Charter of the City of Dallas, and it is accordingly so resolved.
